TTD & Maintenance:

If the weekly benefit rate (66.66% of the AWW) is less than the statutory minimum, the minimum is the weekly benefit.

However, the weekly benefit rate cannot exceed the AWW. Accordingly, if 100% of the AWW is less than the minimum, 100% of the AWW is the minimum weekly benefit.

Wage Differential & Temporary Partial*: Sec. 8(b)2.1 applies the TTD minimum rate to wage differentials & temporary partial benefits.

Note: The editor is not certain how the AWW limitation applies in differential cases involving minimum rates. But based on the TTD computations and how maximum rates have been applied in wage differential decisions, the editor believes the following may be accurate:

Temporary Partial:

- 1. If the AWW on the accident date exceeds the applicable minimum rate, and the <u>differential</u>* is less than that rate, the differential benefit is the minimum rate.
- 2. If the AWW on the accident date is less than the applicable minimum rate, the differential is 100% of the difference between the AWW and the current reduced earnings.

Wage Differential:

- 1. If the applicable AWW* exceeds the minimum rate in effect on the accident date, and the differential* is less than the minimum, the minimum rate is the benefit.
- 2. If the applicable AWW* is less than the minimum rate in effect on the accident date, the differential is 100% of the difference between prior-occupation AWW at the time of arbitration and the reduced AWW attainable as of the date of arbitration.

*The 8(d)1 differential is 66.66% of the difference between the prior occupation's AWW <u>as of the date of arbitration</u> and the reduced AWW the employee can earn as of the arbitration date. But the minimum rate is based on the date of accident. The editor is uncertain if the prior occupation AWW on the accident date or the arbitration date is used to determine the calculation of the minimum rate.

^{*}Differential: 66.66% of difference between the AWW on the accident date and current reduced earnings in temporary restricted duty.

If the weekly benefit rate (60% of the AWW) is less than the statutory minimum, the minimum is the weekly benefit. (Prior to 7/1/1984: 66.66%)

However, the weekly benefit rate cannot exceed the AWW. Accordingly, if 100% of the AWW is less than the minimum, 100% of the AWW is the minimum weekly benefit.
